# What is democracy?

- Conventional meaning: Rule by (will of) the majority (tyranny of the majority??)
- More sensibly: Democracy is a system of government in which state power is vested in the people or the general population of the state.
- QUESTION: Which of these definitions do Namibian leaders and the general populace understand the most?

#### Understanding press freedom

- Simple definition: The right of the media (newspapers, radio, TV etc) to report news without being controlled by government.
- Namibian Constitution, Article 21 (Fundamental Rights): "All persons shall have the right to freedom of speech and expression, which shall include freedom of the press and other media (social media, too?)
- "Freedom of the press is **firmly anchored in Namibia**, historically one of Africa's best-ranked countries in RSF's World Press Freedom Index." Reporters Without Borders, France.

#### Press regulatory environment in Namibia

- Broadcasting regulated by Communication Regulatory Authority of Namibia (CRAN)
- Print and electronic media subjected to Code of Ethics (truth, accuracy, balance, independent (etc).
- ➤ Self-regulation: Media Ombudsman (creation of the Editors Forum of Namibia) enforces Code of Ethics.
- ➤ Like everyone else, media must abide by Namibian Constitution (e.g. protection of rape victims etc)
- > State media often subjected to state control

## Current state of press freedom in Namibia

- ✓ Namibia currently No. 1 in Africa in press freedom
- ✓ No journalist arrested for 34 years (but is this enough yardstick)?
- ✓ New Era managing editor suspended for questioning Judiciary
- ✓ Verbal and legal threats rife
- ✓ Delayed Access to Info Act breeds secrecy
- ✓ Don't forget: Advert ban on The Namibian
